Documents prepared in black ink only.

Documents can be signed and dated in blue

Document margins of half inch.

Blank space required in upper righthand corner of page 1 measuring at least 3" x 5" measured from the margins.

Document shall not have any attachments stapled or otherwise affixed to any page.

No shadowed or grey areas containing information on the document.

Deed must have grantee's address

Will: Black Ink Only
